Fundraising Presentation: Lise Mills, Fundraising Chair thanked those that contributed to this successful event, the November Breakfast Fundraiser. She expressed her appreciation to Mary Beth Hansen, of Paradise Grill for the use of her restaurant and staff for our Breakfast fundraisers. Mary Beth has been a wonderful support to our club. Next to be recognized was Lise's co-Chair, Carolyn Bach, appreciated for her innovative efficiency and problem solving Also thanked was MaryLou Belisles, in charge of the lovely baskets for auction, along with her helpers, Bernie Noviki and Bonnie Burkehalter. Jeana Hilligoss, was noted for solicitation of matching funds from the Community Foundation of Sarasota. Not to be forgotten were members that voted to give the Tidewell Hospice \$500 and members that sold tickets, attended and worked at the Breakfast. Also acknowledged was Dick Gray, Lise's friend, who was attending the meeting to take pictures.

A brief presentation of the background and function of the Tidewell Hospice Honors Program was given by Irene Hendersen. As a veteran Navy nurse, she especially appreciates the donation for this program that serves veterans in multiple counties in our area. This program has been in operation since 1980, with its mission being: 'Helping People Live Well by Providing Comfort, Care and Compassion.' Tidewell Hospice provides a variety of physical, social and mental support services for its veterans and their families. They have served more than 20,091 Veterans since 2008, when statistics were compiled. They offer a unique pinning ceremony for its veterans to honor their service and sacrifice. The Tidewell Hospice has received a Level Five Certification, a status given to only 11 hospices in the US. They now

mentor other Hospice programs to help them achieve this status. A ceremonial check in the amount of \$5881.11 was presented by Lise, Carolyn and Mary Beth to Irene and Kaitlyn. This was very much appreciated as this program is funded by donations.

Musical Program: Laura Hester then introduced our entertainment in honor of St. Patrick's Day: Corodon Fuller, an accomplished pianist and singer, along with Ellie Cruze, a talented singer, a current artist in the 'Watermelon Wine' band. Irish songs, such as "The Wild Rover," "The Unicorn Song" and "Danny Boy" were a few that were played for our group. Words were provided so members could participate as well. Corodon and Ellie provided a delightful presentation for our enjoyment!

Finance Committee Report: Janet Apple, representing the committee gave the presentation. They have discussed budgeting, internal controls, financial planning, and goals, gifting (scholarships), insurance and budget plans; then shared their recommendations with the Board. She discussed parts of the Goals such as gifting recipients and review of investments. It has been recommended that our club return to its original focus of Civic giving.
