- 1. Guest Speaker: Sgt. Sean Hammet of the Venice Police Department
 - His job is Community Outreach: Best job in the PD
 - He gives similar presentations to schools, hospitals, assisted living, HOA
 - His targets are homelessness, mental health issues, and substance abuse
 - To address these issues, the Venice PD has created and Outreach Team approach: Sgt. Hammet has a case manager to help get individuals connected to appropriate resources
 - Try to provide services to the homeless so they stay off the streets
 - There are no homeless shelters in Sarasota County. The Sherriff has 20 hot beds but the person has to go to Sarasota and go through case management
 - Tax season is here and this leads to an increase in scams
 - Elderly are biggest victims
 - Florida leads the country in scams
 - Scams going around
 - Social Security and IRS: they will not call you if there is an issue. They will send you a letter
 - Stay up to date on your credit report: especially check for different addresses
 - Geek Squad FPL are also common scams
 - Don't engage with people asking for money over the phone especially if they have an accent
 - If you see something, say something
